

# SOLO AND ENSEMBLE FESTIVAL STUDENT ELIGIBILITY

West Virginia students grades 4-12 are encouraged to study and perform solo and ensemble literature. Solo and Ensemble eligibility requirements are as follows:

# Public and Private School Eligibility:

- 1. Applicants must be enrolled in a West Virginia school recognized by the West Virginia Department of Education.
- 2. Applicants may attend whichever site they see fit. However, they may only attend 1 festival per scholastic year.
- 3. Applicants must fall into one of the three age categories: Elementary (grade 4&5), Middle School (grades 6-8), or Senior High (grades 9-12).
- Applicants must be sponsored by a current WVMEA/ NAfME member: private and/ or public teacher/ instructor/ director. Current NAfME card must be copied and included in both the festival and honor submission applications.
- Accompanists do not have to hold active membership in WVMEA/ NAfME in order to accompany students. However, they cannot take the place of the primary sponsoring teacher/ instructor/ director.
- Solo and Ensemble participants who are invited to perform on the In-Service Honor Recital must be accompanied to the annual WVMEA In-Service by his/her *primary sponsoring* teacher/ instructor / director, who must be <u>registered</u> for the In-Service to attend.

#### Home-Schooled Student Eligibility:

Home-schooled students are eligible to perform for adjudication during the solo and ensemble events. The following eligibility criteria must be met:

- Applicants may attend whichever site they see fit. However, they may only attend 1 festival per scholastic year.
- 2. Applicants must fall into one of the three age categories: Elementary (grade 4&5), Middle School (grades 6-8), or Senior High (grades 9-12).
- Applicants must be sponsored by a current WVMEA/ NAfME member: private and/ or public teacher/ instructor/ director. Current NAfME card must be copied and included in both the festival and honor submission applications.
- Accompanists do not have to hold active membership in WVMEA/ NAfME in order to accompany students however, they cannot take the place of the primary sponsoring teacher/ instructor/ director.
- 5. Solo and Ensemble participants who are invited to perform on the In-Service Honor Recital must be accompanied to the annual WVMEA In-Service by his/her *primary sponsoring* teacher/ instructor/ director, who must be <u>registered</u> for the In- Service to attend.

#### Fees

All fees associated with the Solo and Ensemble festivals are <u>due at the time of application.</u> All festival and state level fees are non-refundable for any reason. The fee schedule is as follows:

- Solos: \$7.00
- Duets to Sextets (2-6 students): \$10.00
- 7-18 Member Ensembles: \$12.00

#### **Photo Release**

# Directors/ teachers: please share this with your event participants. Compliance is mandatory to be considered for a State Honor's Recital Invitation.

Parents and/or legal guardians of all students, both minor and of-age, who complete and pass the Solo and Ensemble Festival Selection Committee and are invited to perform on the state recital, must authorize the West Virginia Music Educators Association, hereafter referred to as WVMEA, to publish photographs, film and social media posts of minor child or children and their names and likenesses, for use in the WVMEA's print, online and video-based marketing, its contractors, its employees and any third parties involved in the creation or publication of Beaver Media Productions, from liability for any claims by any parent or any third party in connection with the participation of the minor children, materials, as well as other WVMEA publications. Parents must release and hold harmless WVMEA from any reasonable expectation of privacy or confidentiality for any participating minor child and children listed below associated with the images or video specified above.

#### **Ramifications/ Sanctions**

- If any ineligible student is found participating in a Solo and Ensemble, he/she will be immediately removed. He/she will be declared ineligible for an invitation for the State Honor Recital the next year even if he/she meets requirements. Any fee associated with the Solo and Ensemble will not be returned.
- Should any WVMEA member sign a Solo and Ensemble application for an ineligible student, no applications signed by that WVMEA member will be accepted the following year.
- 3. If any eligible student is found participating in more than one festival per scholastic year, he/she will be immediately removed. He/she will be declared ineligible for an invitation to the State Honor Recital the next year even if he/she meets requirements. He/she will also have their festival ratings revoked. Any fee associated with the Solo and Ensemble festivals will not be returned.
- Should any WVMEA member sign more than 1 Solo and Ensemble application for a student in multiple site locations, no applications signed by that WVMEA member will be accepted the following year.



# SOLO AND ENSEMBLE REGULATIONS

Solo and Ensemble Festivals throughout West Virginia are run consistently from site to site. Other students and parents are encouraged to listen to one another's performance. Listed below are the regulations that all participants must adhere to and abide by.

#### Ensembles

- Ensembles may not have more than 18 members.
- Instrumental ensembles are urged to assign one player per part.
- Ensembles of 6 or less members (high school age) should not be conducted.
- Ensembles of 7 or more can be conducted if desired.
- Elementary and middle school ensembles can be conducted if desired.

#### **Musical Selections**

- There is no required music list.
- Memorization of solos is encouraged but not required.
- Ensemble music does not need to be memorized.
- Eight (8) minute maximum per each performance.
- If the selection calls for piano accompaniment, performers are urged to use it. However, their overall rating will not be affected by the lack of accompaniment. If a student is nominated for the state honors recital their recorded submission must include a live accompaniment if it is written in the music unless it is specified as optional by the composer or arranger.
- Smart Music, pre-recorded accompaniment and other like programs are permitted to be used to accompany performances at the festival level. Note: Students who may be selected to submit a recording for consideration for the State Honors Recital must use a live accompanist in their recorded submissions. Under no circumstances will electronic accompaniment be permitted on the State Honors Recital. Site chairs are under no obligation to provide any materials for facilitating electronic accompaniment. <u>The student(s)/ teacher are responsible for providing their own amplification, playback devices, computers, etc.</u>
- All state honors recital performances must include a live accompaniment part if it is included in the music unless it is specified as optional by the composer or arranger.
- Judges must be furnished with a copy of the sheet music with the measures numbered.
  Photocopies are not to be used without proof of publisher's permission.

# Adjudication

- All festival entries will receive a rating (1 through 5) unless otherwise indicated <u>before</u> the performance begins. Judges can submit 'comments only' upon request.
- Judges will consider the grade level of each performer/ ensemble.

- Concerning mixed ensembles (both at festival and state level):
  - Ensembles with 7th and 8th graders will be considered a 'middle school ensemble.'
  - Ensembles that have 9th graders or above will be considered a senior high ensemble.
- The rating scale is as follows:
  - 1 = Superior
  - 2 = Excellent
  - 3 = Good
  - 4 = Fair
  - 5 = Developing
- Judges are not permitted to aide or coach any student performer(s).
- All adjudications must take place on the same day.
- Adjudicators must stay consistent throughout the course of the festival. I.e. all percussion performances must be adjudicated by the same person.
- Judges under no circumstances are permitted to participate in a performance.
- A performance may only be adjudicated once.
- Any performance receiving a superior '1' rating shall be considered a nomination for the state honors recital.

# **Copyright / Arrangements**

- Teachers and students must follow Federal copyright laws in providing music for all performers.
- Adjudicators must be provided with a legal copy of the music to be performed.
  - For a photocopy to be considered legal you must have written permission from the owner/publisher of the music.
  - $\circ$  Attach a letter granting permission to photocopy to any copies being used .
- Teachers and students must follow Federal copyright laws concerning personal arrangements or alterations.
  - For an arrangement to be considered legal you must have written permission from the owner/publisher of the music.
  - Attach a letter granting permission to arrange to any music being used.

#### **Inclement Weather Policy**

 In the event that a festival must be cancelled due to inclement weather, all applicants from that festival may submit state honors recordings for consideration.

#### **State Honor Recital**

- Performances receiving a '1' may submit a recording of their performance to be considered for inclusion in the State Honor Recital held in March during the In-Service.
- Additional applications and fees must be submitted and complete.
- Submitted recordings will be adjudicated by a Honors Recital Committee. (see above concerning electronic accompaniment)
- *ALL* Honors Recital submissions will be made electronically beginning in 2019. Electronic submission sites will be posted on the WVMEA website.
  - All electronic submissions MUST be in MP3 format due to file size restrictions.

# To The Adjudicators:

- Adjudicators will be paid \$75 for a half day of work (up to 4 hours) and \$150 for a full day of work (any time over 4 hours).
- Adjudicators must hold an undergraduate degree in music or a professional equivalent.
- Adjudicators must complete the free NFHS Music Adjudication course once every five years.
  Proof of completion must be submitted to the site chair before you may adjudicate any students.

- All performances receiving a superior '1' rating will be considered as nominations for the state honors recital process.
- Certificates should be awarded for '1' ratings.
- Make comments as constructive as possible.
- Sign ratings sheets.
- Submit ratings to site chairs.

# To the Site Chairs:

- Site chairs must be active members of the West Virginia Music Educators' Association by September 1<sup>st</sup> of each year.
- All site chairs must complete the free NFHS Music Adjudication course once every five years.
  Proof of completion must be submitted to the state chair before September 1<sup>st</sup> of every 5<sup>th</sup> year.
- Site chairs are responsible for enforcing all of the rules and regulations above to the best of their ability.

 All site chairs must attend the Solo and Ensemble meeting at the annual WVMEA In-Service. Any unavoidable absences must be cleared with the state solo and ensemble chair ahead of time.
